## North Fresno Rotary Endowment - Grant Criteria

North Fresno Rotary Endowment Grant requests must be for a capital project, good, or item(s), in Fresno and/or Madera County, and must meet at least one of the following six criteria:

- 1. Make a significant impact on youth, the disadvantaged, or those elements of our community not adequately serviced by other avenues of support:
- 2. Are for new tangible projects as opposed to well-funded or well-established projects;
- 3. Are for projects in the greater Fresno area, or that primarily benefit the residents of Fresno;
- 4. Are under the direction of a local organization or local affiliate:
- 5. Are for capital equipment, good, or items; and
- 6. Provide proven sustainable benefits that is, provide benefits to the community that continue long after the grant has been disbursed.
